



WV TACSEI Master Cadre Application

West Virginia is one of two states recently selected to participate in a technical assistance and training partnership with the Technical Assistance Center on Social Emotional Intervention (TACSEI) and the Center for Early Literacy Learning (CELL). The West Virginia Department of Education, Office of Special Education Programs, and WV Birth to Three, Department of Health and Human Resources, applied for this grant in conjunction with many other early childhood partners. Through this exciting partnership, the state will develop an integrated early childhood training system to promote social, emotional, and early language and literacy competence, and prevent challenging behaviors in all young children birth to age five.

The Center for Early Literacy Learning (CELL) is a research - to - practice technical assistance center funded by the U.S. Department of Education, Office of Special Education Programs, Research to Practice Division. The main goal of CELL is to promote the adoption of and sustained use of evidence-based early literacy learning practices by early childhood intervention practitioners, parents and other caregivers of young children, birth to five years of age, with identified disabilities, developmental delays, and those at risk for poor outcomes.

The Technical Assistance Center on Social Emotional Intervention (TACSEI) is a research-to –practice technical assistance center funded by the U.S. Department of Education, Office of Special Education Programs. The main goal of TACSEI is to promote the adoption of and sustained use of evidenced based practices referred to as the "Pyramid Model" for supporting social emotional competence and preventing and addressing challenging behavior of young children with or at risk for delays or disabilities.

To meet these goals, the WV CELL/TACSEI Partnership is dedicated to building state capacity to foster professional development of the early care and education workforce that:

- 1. enhances knowledge and skills
- 2. supports the implementation and sustainability of evidence-based practices
- 3. increases the size of the workforce skilled in supporting the early literacy, learning and social-emotional development of young children (birth–5 years) in inclusive, natural environments
